
### **The Ability Center of Greater Toledo**

### **ACT: Organization Chart**





### **ACT: Assistance Dogs**

 Assists individuals in achieving greater independence by training and placing service and therapy dogs to assist with the individual's daily needs. Assistance Dogs has helped transform the lives of over 160 individuals and their communities.

  - Over 500 transitioned to date!
- Home Modification
  - 179 projects completed 2010/11

### **ACT: Community Connections**

- Create and support community options for people living with disabilities by assisting individuals in developing goals, identifying dreams, and defining their vision for their life.
- Assists individuals in achieving their personal goals by making appropriate connections within the community and providing necessary information, resources, accommodations, and support.

Using an enjoyable mix of videos, speakers, discussions and hands-on activities, our training sessions are specifically designed to give each participant a deeper appreciation of the issues and obstacles faced by people living with disabilities in everyday life.
